### **RULES OF CONVENTION**

#### Admission:

- 1. Delegates and visitors must register before attending convention business meetings.
- 2. Admission to business meetings of convention shall be by showing convention badge.

### General:

- 3. Members are requested to be in their seats for the call to order.
- 4. Remain seated for the processional and the recessional.
- 5. No photos or videos, including live streaming, shall be taken during a business meeting. All electronic devices (e.g., iPads, laptops, cellular phones, tape recorders, camcorders, and pagers) shall not be used during meetings. Exception: The state secretary may use a laptop for her assigned duties.
- 6. Place cell phones on silent mode.
- 7. Messages shall be given to and delivered by convention assistants or pages and guards except
  - during speeches or musical presentations.
- 8. Inability to hear shall be signified by raising the hand.
- 9. A committee, appointed by the president, has the responsibility to read and approve the minutes of convention.
- 10. Addresses, remarks, and answers to questions given by the representative of International Chapter shall not be taped, duplicated, or distributed.

### **Speaking and Voting:**

- 11. Only voting members of convention are allowed to speak and vote on a subject.
- 12. A member addressing the presiding officer shall give her name and chapter letter(s) before being recognized.
- 13. When speaking to an amendment, no member shall speak more than once and for more than one (1) minute. Total time on a proposed amendment shall be limited to 7 minutes. The speaker will use a floor microphone.
- 14. Amendments adopted at convention will take effect at the close of convention or as instructed in state bylaw.

# MINUTES OF CONVENTION OPENING MEETING

### Friday Afternoon, April 26, 2024 1:30 PM

1:15 pm Guards in place Convention Hall-Main Ballroom
The 65<sup>th</sup> Annual Convention of the Alabama State Chapter of the P.E.O. Sisterhood convened at 1:30 pm, Friday,
April 26, 2024, at the Auburn Marriott Opelika Resort and Spa at Grand National. Chapters G, K, AE, and AG
served as hostesses.

*Alabama's Mountain Music* was played during the processional for the Alabama State Chapter Executive Board, Representative of International Chapter, and Past State Presidents (PSPs).

The meeting was called to order by President Cindy Fry at 1:30 pm.

Elizabeth Davis, Chapter D, delivered the invocation.

Ruth Guertin, Chapter AD, led the Pledge of Allegiance.

Sally Priester, Chapter AD, led the singing of "O Canada" and "The Star-Spangled Banner."

President Cindy Fry welcomed all attendees to the 65th Annual Convention of Alabama State Chapter.

The assistant guards took their places, and Head Guard, Courtney Fry, Chapter AL, gave the report of the guards.

President Cindy Fry thanked each sister of the hostess chapters for all their hard work over the past year.

President Cindy Fry introduced the Alabama State Chapter Historian, Lori Rodgers, Chapter AD.

President Cindy Fry introduced Mary Wiley, PSP, Chapter AJ, as the Advisor to the Guards, Tellers, and Pages. The guards were recognized: Head Guard: Courtney Fry, Chapter AL; Carole Worsham, Chapter, AD; Sally Priester,

Welcoming remarks by the Convention Chair were presented by Susan Heiser, Chapter AP.

Secretary Nancy Newton, on behalf of the Alabama State Chapter of P.E.O., expressed appreciation and thanks to Chapter G, K, AE, and AG for hosting this 65<sup>th</sup> Annual Convention of the State Chapter.

The president noted that, in the Rules of Convention, a committee to approve minutes was authorized. The committee members were announced as Barbara Tonn, Chapter AL, Nancy Sites Sizemore, PSP, Chapter AG, and Luann Rice, Chapter C.

The president appointed Terry Northcutt, Representative of International Chapter, as convention parliamentarian.

President Cindy Fry and Organizer Cel Bailey presented charters to two new Alabama local chapters: Chapter AO, Montevallo, AL, and Chapter AP, Gadsden, AL.

Organizer Cel Bailey, presented Chapter R, with a Certificate of Reorganization. This process of rejuvenation of a chapter, "Chapter Vitalization Program," was conducted over the last two years. Special thanks were given to Gayle Howell, PSP, Chapter AC, for her help in this reorganization.

The secretary read correspondence from Cathy Moss, president of International Chapter of the P.E.O. Sisterhood.

Terry Northcutt, Representative of International Chapter gave the keynote address. The address was untitled. The president thanked her for her inspiring message.

Organizer Cel Bailey, conducted a Period of Instruction (POI) entitled "Video - Virtual Ceremony of Initiation."

The next item of business was the annual reports of the state officers, which were included in the convention program for all to read. Additionally, reports of Standing Committees and State Philanthropies were included in the convention program as well and will be in the proceedings. It was noted that donations are being accepted to vote on the best philanthropy display with the winner receiving all donations to that project.

The State Historian, Lori Rodgers, Chapter AD, presented the state's history for the year. President Cindy Fry reminded all that the historian display was also in the display area for viewing. Photos of the convention will be added to the State's scrapbook upon completion.

The next order of business was the election of officers. There being no further nominations from the floor, the nominations were declared closed. There being no objection, the written ballot was dispensed with, and a voice vote taken. The election of officers was completed, and the following members were declared elected as officers of Alabama State Chapter for the ensuing year.

The president announced the installation of new officers would take place during the third meeting on Saturday, April 27.

President Cindy Fry called attention to the proposed 2024-2025 budgets (provided to each member of convention in their packet of information). The chair of the Finance Committee, Janice Alcorn, PSP, Chapter AN, was called away from convention, and Denise Williams. PSP, Chapter U introduced the other members of the committee: Susan Richardson, Chapter C, and Julia Naefe, Chapter AL. Denise presented the proposed budgets and moved that the report be adopted.

This question was divided into three separate questions:

- 1) adoption of budgets;
- 2) transfer of funds \$6,000 from the General Fund to the Convention Fund;
- 3) the remainder of the report.

There being a majority of votes in the affirmative, the budgets for 2024-2025 were approved. There being a majority of votes in the affirmative, the transfer of funds of \$6000 from the General Fund to the Convention Fund was approved. There being a majority of votes in the affirmative, the remainder of the report was approved. The president stated that the adoption of the report approved the Report of the Treasurer.

The president thanked the members of the Finance Committee for their careful attention to the financial details of Alabama State Chapter and for making recommendations as needed this past year. She announced the audit report and the gift log were on display near the exit of the convention hall.

In preparation for the presentation of amendments to the Bylaws and Standing Rules of the Alabama State Chapter, the president requested all members of convention to be in their assigned seats. She instructed the convention in the procedure for presentation of amendments and voting. In accordance with the Rules of Convention, amendments adopted take effect at the close of convention, as specified in the Bylaws and Standing Rules of Alabama State Chapter.

The report of the Amendments and Recommendations (A&R) Committee was given by the chair, Mavis Smith, Chapter AO. The chair introduced the other members of the committee: Gayle Howell, PSP, Chapter AC and Carol Fischer, Chapter T.

The chair presented the 2024 proposed amendments to the Bylaws of Alabama State Chapter. Page numbers refer to the 2023 Bylaws and Standing Rules of Alabama State Chapter.

### PROPOSED AMENDMENTS TO THE BYLAWS OF ALABAMA STATE CHAPTER

### 1. Submitted by the Executive Board of the Alabama State Chapter.

(page B-4) Amend ARTICLE V, Section 2, bullet 1, by striking out the words "residing in the state" so that if adopted the bullet will read:

A convention fee of three dollars (\$3.00) per active chapter member.

A written ballot was taken with the following results: 107 votes cast, 68 needed for adoption by two-thirds, 104 affirmative and 3 negative. The amendment was adopted.

### 2. Submitted by the Executive Board of the Alabama State Chapter.

(page B-5) Amend ARTICLE V, Section 6, paragraph 1, by inserting a new sentence 4, so that if adopted it will read:

The state chapter will incur the cost of housing, at a half room rate, when it is necessary for entitled members of convention to arrive the day before the start of convention activities.

A written ballot was taken with the following results: 105 votes cast, 68 needed for adoption by two-thirds, 102 affirmative, 2 negative and 1 illegal. The amendment was adopted.

### 3. Submitted by the Executive Board of the Alabama State Chapter.

(page B-8) Amend Article IX, Section 1, bullet 1, sentence 3, by inserting the word "absent" following the words "sent to" so that if adopted the subsection will read:

To write an annual letter and report to the president of the state chapter informing her of the activities and status of the chapter. The letter and report shall be read and approved at a chapter meeting in February and mailed before March 1. A copy of this letter and report shall be retained in the local chapter president's box and copies shall be sent to absent members.

The amendment was adopted.

#### **EDITORIAL RESOLUTION**

At the direction of the A&R Committee, the A&R Chair moved the adoption of the following editorial resolution:

*Resolved*, That the 2024-2025 Executive Board of Alabama State Chapter be authorized to correct article and section designations, punctuation, and cross-references and to make such other technical and conforming changes as may be necessary to reflect the intent of Alabama State Chapter.

The editorial resolution was adopted.

Since there was no objection and the addendum had been distributed and no discussion or vote required, the president announced that the addendum is a result of the action taken at the 2023 Convention of International Chapter and would not be read but would be included in the convention minutes and the changes would be made in the next printing and posting of the Alabama State Chapter Bylaws and Standing Rules.

### **ADDENDUM**

The following changes are to be made in the Bylaws and Standing Rules of Alabama State Chapter in order to conform with the Constitution, Bylaws and Standing Rules of the P.E.O. Sisterhood, as amended at the 2023 Convention of International Chapter.

1. Each s/p/d chapter shall increase annual dues to International Chapter from twenty-six dollars (\$26.00) to thirty-six dollars (\$36.00) with the proviso to implement the increase in two steps.

(page B-4) ARTICLE V -- FINANCE, Section 1—DUES will now be stated as:

Section 1—DUES. The annual dues of Alabama State Chapter shall be fifty-one dollars (\$51.00)\* per active member, which shall be allocated as follows: Thirty-six dollars (\$36.00)\* for International Chapter dues, which shall include six dollars (\$6.00) for Cottey College; and fifteen dollars (\$15.00) for state chapter dues.

\*PROVISO: The increase of International Chapter dues to thirty-six dollars (\$36.00) shall be implemented in two steps: an increase of five dollars (\$5.00) to thirty-one dollars (\$31.00) for the 2024-2025 fiscal year; and an increase of five dollars (\$5.00) to thirty-six dollars (\$36.00) beginning the 2025-2026 fiscal year. The total annual dues of Alabama State Chapter shall be forty-six dollars (\$46.00) for the 2024-2025 fiscal year and fifty-one dollars (\$51.00) beginning the 2025-2026 fiscal year.

2. Each s/p/d chapter shall remove the words "resident" and "nonresident" when reference is made to active local chapter members.

(page B-8) ARTICLE IX -- SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS, Section 1—PRESIDENT, bullet 1, sentence 3 will now be stated as:

A copy of this letter and report shall be retained in the local chapter president's box and copies shall be sent to members.

NOTE: This change will only take place if amendment #3 is defeated.

(page B-9) ARTICLE XIV -- AMENDMENTS, Section 1—PROCEDURE, sentence 2 will now be stated as:

Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular meeting provided the amendment was submitted in writing at a previous regular meeting and all absent members notified that a vote will be taken at the next regular meeting.

At the direction of the Executive Board of International Chapter based on the opinion of legal counsel, the following change is to be made in the Bylaws of Alabama State Chapter. This change requires no vote by convention.

1. No s/p/d shall have provisions in their bylaws that conflict with applicable governmental laws. All s/p/d chapter bylaws shall include an article stating that the bylaws shall comply with governmental laws applicable to the operation of the s/p/d chapter.

(page BL-9) A new ARTICLE XIV will be inserted in the bylaws and will be stated as:

### **ARTICLE XIV -- GOVERNING LAW**

These bylaws shall comply with governmental laws applicable to the operation of the state chapter.

**NOTE**: The subsequent article will be renumbered to conform.

The president thanked the members of the A&R Committee for their hard work and amazing collaboration.

While vote tallying occurred, Secretary Nancy Newton announced and congratulated birthday chapters for the State this year. They were Chapter AA, 30 years; Chapter Y, 35 years; Chapter S, 45 years; Chapter Q, 50 years; and Chapter C, 75 years.

The Membership Committee Chair, Shirley Paramore, PSP, Chapter V, with help from the committee members Luann Rice, Chapter C, and Lisa Vardaman, Chapter AF, (Karen Sargent was unable to attend) conducted a membership workshop entitled "Plant the Seeds of Membership."

Announcements were made by the Convention Chair, Susan Heiser.

The president declared the convention adjourned until Saturday, 9:00 AM.

President Cindy Fry called the second meeting of the 65<sup>th</sup> Convention of Alabama State Chapter to order at 9:12 AM.

The assistant guards took their place and the head guard, Courtney Fry, Chapter AL, gave the report of the guards. Additional visitors were recognized.

The second report of the Credentials Committee was given by the chair, Pat Franklin, PSP, Chapter G. 104 members of convention were reported. On behalf of the committee, Pat Franklin moved that the report be adopted. There being a majority in the affirmative, the second report was adopted.

President Cindy Fry updated the convention of the "You Add 2 P.E.O. Initiative" progress in Alabama. Alabama has achieved the requested benchmarks in the 2024 year. The benchmarks were a 2 % increase in Initiations (69 were initiated) and 2% increase in Reinstatements (11 were reinstated). The 2% decrease in Inactive members was not achieved. #### **Membership Committee Report**

- The Alabama State Membership Committee, including our adviser Cel Bailey, state organizer, began monthly meetings (via Zoom) following the Alabama State Convention in May 2023. We did not meet in September or December, but we had two meetings per month in January and March. Becky Clines, our Regional Membership Representative, joined us in August and continued to join us at each monthly meeting thereafter. Becky has been a real asset to our meetings, and we have valued her input to help us increase the vitality of each chapter.
- We reviewed the duties of the committee and assigned regions to each member of the committee. Karen was assigned to all the chapters in North Alabama and Shirley communicated with the Birmingham chapters plus Anniston. Lisa was responsible for the Tuscaloosa, Montgomery, and Auburn chapters, while LuAnn communicated with the chapters in Mobile, Daphne, Foley, Dothan, Ozark, Troy, and Prattville.
- We decided to continue with the "Minute for Membership," and each member was assigned the responsibility of preparing this newsletter for three separate months of the year to send to the local membership chairs and encouraged them to share the info to all sisters in the chapter. This newsletter was our primary tool of communication.
- Each committee member completed the on-line portal training workshop that the International Chapter presented, and all felt we had a better understanding of the different reports available to us to help in fulfilling our duties.
- We continued to emphasize the importance of the unaffiliate listing and encouraged the local chapter membership chairs to contact names on this listing and report back to the committee the results of this contact. Chapters have indicated in their Annual Reports that they would like a better understanding of the unaffiliate listing; therefore, a zoom workshop is being planned to help chairs and chapters gain more knowledge on this significant area of P.E.O.
- We asked chapters to review the chapter inactive list for possible reinstatements. We suggested the chapters, if they do not already do so, to consider printing this list in their yearbooks.
- We held discussions on Reciprocity and the role of Reciprocity in our state. One area (Wiregrass) does not have a Reciprocity Group. Reciprocities are active in North Alabama, Auburn, Birmingham, Tuscaloosa, Montgomery, and Mobile. It is felt that most chapters enjoy getting together once or twice a year.
- We planned a workshop for the Alabama State Chapter Convention as it is emphasized that Membership should always have a presentation as part of the convention as well as a Membership Display. The theme for the workshop and display will be "Plant the Seeds of Membership."
- From March 1, 2023, through February 29, 2024 69 new initiates, 34 transfers, 11 reinstatements, 28 transfers to other chapters, 31 sisters entered Chapter Eternal, and 78 sisters chose to go inactive.



# 2024 NOMINEE TO THE ALABAMA STATE BOARD Chery Williams, Chapter AG

I was employed by the USDA from 1976-1991. My work with the USDA was instrumental in the development of chicken nuggets and patties for the United States Military and United States School Lunch Program. I earned four licenses in the poultry industry and one in the beef industry.

When my family lived in Albertville, Alabama, I was involved in the Albertville City School System as an ESL aid, substitute teacher, class volunteer, and Odyssey of the Mind coach. # PROPOSED AMENDMENTS TO THE BYLAWS AND STANDING RULES OF ALABAMA STATE CHAPTER

(Page numbers refer to the 2023 printing/posting of the Bylaws and Standing Rules of Alabama State Chapter)

#### PROPOSED AMENDMENTS TO THE BYLAWS OF ALABAMA STATE CHAPTER

#### 1. Submitted by the Executive Board of the Alabama State Chapter.

(page B-4) Amend ARTICLE V, Section 2, bullet 1, by striking out the words "residing in the state" so that if adopted the bullet will read:

A convention fee of three dollars (\$3.00) per active chapter member.

**EXPLANATION:** Would require each local chapter to send annually with dues, a state convention fee of three dollars (\$3.00) per active member; and would remove the exemption for members living outside of the state.

**RATIONALE:** Online annual reporting no longer has the capability to separate sisters residing in or out of state for collection of a convention fee.

### 2. Submitted by the Executive Board of the Alabama State Chapter.

(page B-5) Amend ARTICLE V, Section 6, paragraph 1, by inserting a new sentence 4, so that if adopted it will read:

The state chapter will incur the cost of housing, at a half room rate, when it is necessary for entitled members of convention to arrive the day before the start of convention activities.

**EXPLANATION:** Would provide that the state chapter will incur the cost of housing, at half-room rate, when it is necessary for entitled members of convention to arrive the day before the start of convention activities.

**RATIONALE:** Voting members of Convention of International Chapter are required to attend a Credentials dinner the night before convention starts.

#### 3. Submitted by the Executive Board of the Alabama State Chapter.

(page B-8) Amend Article IX, Section 1, bullet 1, sentence 3, by inserting the word "absent" following the words "sent to" so that if adopted the subsection will read:

To write an annual letter and report to the president of the state chapter informing her of the activities and status of the chapter. The letter and report shall be read and approved at a chapter meeting in February and mailed before March 1. A copy of this letter and report shall be retained in the local chapter president's box and copies shall be sent to absent members.

**EXPLANATION:** Would remove the requirement that all members shall be sent the local chapter president's annual letter; and would stipulate that absent members shall be sent a copy of the local chapter president's annual letter.

**RATIONALE:** Members of a chapter in attendance at the February meeting will hear the President's letter. By sending the annual president's letter to absent sisters, they will be more connected with the activities of the chapter.

#### **EDITORIAL RESOLUTION**

*Resolved*, That the 2024-2025 Executive Board of Alabama State Chapter be authorized to correct article and section designations, punctuation and cross-references and to make such other technical and conforming changes as may be necessary to reflect the intent of Alabama State Chapter.

#### **ADDENDUM**

The following changes are to be made in the Bylaws and Standing Rules of Alabama State Chapter in order to conform with the Constitution, Bylaws and Standing Rules of the P.E.O. Sisterhood, as amended at the 2023 Convention of International Chapter. These changes require no vote by convention.

1. Each s/p/d chapter shall increase annual dues to International Chapter from twenty-six dollars (\$26.00) to thirty-six dollars (\$36.00) with the proviso to implement the increase in two steps.

(page B-4) ARTICLE V -- FINANCE, Section 1—DUES will now be stated as:

<u>Section 1—DUES</u>. The annual dues of Alabama State Chapter shall be fifty-one dollars (\$51.00)\* per active member, which shall be allocated as follows: Thirty-six dollars (\$36.00)\* for International Chapter dues, which shall include six dollars (\$6.00) for Cottey College; and fifteen dollars (\$15.00) for state chapter dues.

\*PROVISO: The increase of International Chapter dues to thirty-six dollars (\$36.00) shall be implemented in two steps; an increase of five dollars (\$5.00) to thirty-one dollars (\$31.00) for the 2024-2025 fiscal year; and an increase of five dollars (\$5.00) to thirty-six dollars (\$36.00) beginning the 2025-2026 fiscal year. The total annual dues of Alabama State Chapter shall be forty-six dollars (\$46.00) for the 2024-2025 fiscal year and fifty-one dollars (\$51.00) beginning the 2025-2026 fiscal year.

2. Each s/p/d chapter shall remove the words "resident" and "nonresident" when reference is made to active local chapter members.

(page B-8) ARTICLE IX -- SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS, Section 1—PRESIDENT, bullet 1, sentence 3 will now be stated as:

A copy of this letter and report shall be retained in the local chapter president's box and copies shall be sent to members.

**NOTE:** This change will only take place if amendment #3 is defeated.

(page B-9) ARTICLE XIV -- AMENDMENTS, Section 1—PROCEDURE, sentence 2 will now be stated as:

Local chapters desiring to submit an amendment must have that proposal approved by a twothirds vote at a regular meeting provided the amendment was submitted in writing at a previous regular meeting and all absent members notified that a vote will be taken at the next regular meeting.

At the direction of the Executive Board of International Chapter based on the opinion of legal counsel, the following change is to be made in the Bylaws of Alabama State Chapter. This change requires no vote by convention.

1. No s/p/d shall have provisions in their bylaws that conflict with applicable governmental laws. All s/p/d chapter bylaws shall include an article stating that the bylaws shall comply with governmental laws applicable to the operation of the s/p/d chapter.

(page BL-9) A new ARTICLE XIV will be inserted in the bylaws and will be stated as:

#### ARTICLE XIV -- GOVERNING LAW

These bylaws shall comply with governmental laws applicable to the operation of the state chapter.

**NOTE:** The subsequent article will be renumbered to conformed



#### **BYLAWS & STANDING RULES**

#### **BYLAWS**

#### ARTICLE I -- CONVENTION OF ALABAMA STATE CHAPTER

<u>Section 1—MEMBERS</u>. The Convention of Alabama State Chapter shall consist of the following active members, when present and registered:

- · The executive board
- · Past presidents of the state chapter
- · Resident past presidents of International Chapter
- · Two delegates from each local chapter, the president being a delegate when feasible
- · Chair of the Amendments and Recommendations Committee
- Chair of the Nominating Committee
- · Chair of the Finance Committee
- Chair of the Membership Committee
- · Chair of the Alabama Cottey College Scholarship and Recruitment Committee
- · Chair of the P.E.O. Educational Loan Fund Committee
- · Chair of the P.E.O. International Peace Scholarship Committee
- Chair of the P.E.O. Program for Continuing Education Committee
- · Chair of the P.E.O. Scholar Awards Committee
- · Chair of the P.E.O. STAR Scholarship Committee
- Historian

Section 2—TIME AND PLACE/FORMAT. The Convention of the Alabama State Chapter shall be held annually in April or May, dates and place to be proposed by the convention chair and hostess chapters with final approval by the executive board. If determined by the executive board and approved by the Executive Board of International Chapter, convention may be conducted through the use of internet meeting services.

<u>Section 3—HOSTESS CHAPTERS</u>. The local chapters, grouped geographically by the executive board, shall arrange for housing and meals for the convention of the state chapter. No chapter shall be asked to serve as hostess for the convention of state chapter until five years after organization.

<u>Section 4—REPORTS</u>. Within one month following convention, delegates shall make a report of convention business to their respective chapters.

<u>Section 5—FORMAL ACTION</u>. Any item passed by Convention of Alabama State Chapter shall become effective, unless otherwise ordered, at close of the convention and shall be implemented by local chapters upon receipt of the PROCEEDINGS of Alabama State Chapter.

#### ARTICLE II - REPRESENTATION IN INTERNATIONAL CONVENTION

<u>Section 1—DELEGATES</u>. Delegates to Convention of International Chapter shall be chosen in rotation from geographical groups of seven local chapters or major fraction thereof. Grouping of local

chapters for representation in Convention of International Chapter shall be arranged by the executive board, and these groupings shall be printed annually in the convention proceedings.

<u>Section 2—NOMINATION AND ELECTION OF DELEGATES</u>. Local chapters entitled to representation in Convention of International Chapter shall nominate a delegate and an alternate at the time of the annual election by or at the first regular meeting in March. Names of the nominees for delegates shall be submitted as required by International Chapter and presented to the following convention of the state chapter for election. Only those nominees who are members of that convention or of any previous convention of the state chapter shall be eligible.

Section 3—PAST PRESIDENTS OF THE STATE CHAPTER. Designation of the past presidents of the state chapter and their alternates entitled to housing and meals, to be paid for by International Chapter, at the Convention of International Chapter shall be made by those past presidents in attendance at convention of the state chapter preceding the Convention of International Chapter.

Section 4—VACANCY IN DELEGATION. In case of a vacancy, the president of the state chapter shall appoint as delegate: First, the nominee for alternate, elected by the local chapter; second, another member of the chapter entitled to representation; third, a member from another chapter in the group; fourth, a member from the state chapter at large. In case of a vacancy in the representation of past presidents entitled to housing and meals, the president shall appoint an alternate designated by the past presidents' group.

<u>Section 5—REPORTS</u>. The Executive Board will prepare a report to be distributed to the local chapters in writing, electronically, or through another medium accessible to the local chapter.

#### ARTICLE III - NOMINATION AND ELECTION OF OFFICERS

<u>Section 1—ELIGIBILITY</u>. Any member of convention who has been duly elected and installed and served at least one year as president of a local chapter shall be eligible for election to an office in the state chapter. The duties of elected officers of a state chapter are of sufficient importance to require their presence in the state during their terms of office.

<u>Section 2—SEQUENCE OF OFFICERS</u>. The sequence of state chapter officers shall be president, vice president, organizer, treasurer, and secretary.

Section 3—NOMINATION OF OFFICERS. A nominating committee of three members shall be appointed by the incoming president, with the approval of the executive board. The Chair shall be a recent Past State President and the other two members shall be selected from different geographical areas of the state.

At the convention of the state chapter, the committee shall present the name of one nominee for each office. Further nominations may be made from the floor for each office preceding the elective ballot for that office. Prior to nomination, all nominees shall have consented to serve if elected. The report of the nominating committee shall be given preceding the close of the first session of convention.

<u>Section 4—ELECTION OF OFFICERS</u>. Election of officers shall be by written or electronic ballot. If there are no further nominations from the floor for each office called for in sequence, by general consent, the ballot may be dispensed with and the vote taken for the ticket viva voce. If there are nominations from the floor for one or more offices, separate elective ballots shall be taken. A majority of votes cast shall elect.

## ARTICLE IV - SPECIAL DUTIES OF STATE OFFICERS

The following duties are in addition to those listed in the Constitution, Part II, Article VIII and in the Instructions to Officers of State Chapter.

#### Section 1—PRESIDENT. The duties of the president shall be as follows:

- To appoint necessary members to the following committees at the beginning of her term of
  office and to fill any vacancies, with the approval of the executive board:
  - o A member to the Amendments and Recommendations Committee
  - o A member to the Finance Committee
  - A member to the Alabama Cottey College Scholarship and Recruitment Committee
  - o A member to the P.E.O. Educational Loan Fund Committee
  - A member to the P.E.O. International Peace Scholarship Committee
  - A member to the P.E.O. Program for Continuing Education Committee
  - o A member to the P.E.O. Scholar Awards Committee
  - o A member to the P.E.O. STAR Scholarship Committee
  - A Historian
  - A Nominating Committee of three members
  - o An Auditing Committee
- To appoint such special committees as may be authorized by the executive board or a convention of the state chapter.
- To serve as an ex-officio member, without vote, of all standing committees, except the Nominating Committee.
- To provide information on various subjects to local chapters and Past State Presidents periodically throughout the year.
- To proofread the proceedings of convention and bylaws and standing rules of the state chapter following the expiration of her term of office.
- · To act as Chair of the Alabama delegation to Convention of International Chapter.

#### Section 2—VICE PRESIDENT. The duties of the vice president shall be as follows:

- To serve as adviser to the Alabama Cottey College Scholarship and Recruitment Committee.
- · To serve as ex-officio member, without vote, of the Finance Committee.

#### Section 3—ORGANIZER. The duties of the organizer shall be as follows:

- To visit, or direct her proxy to visit, those chapters scheduled for visits, giving the chapters at least thirty days' notice.
- To serve as contact person for P.E.O. Groups and Reciprocity Groups.
- · To serve as adviser to the Membership Committee.
- To serve as adviser to the P.E.O. STAR Scholarship Committee.

## <u>Section 4—TREASURER</u>. The duties of the treasurer shall be as follows:

- To provide the Finance Committee with the information necessary for its work.
- To serve as ex-officio member, without vote, of the Finance Committee.
- To have the books of the treasurer audited at the end of the fiscal year.
- To serve as adviser to the P.E.O. Educational Loan Fund and P.E.O. Program for Continuing Education Committees.

Section 5—SECRETARY. The duties of the secretary shall be as follows:

- To inspect local chapter yearbooks and send a copy of the written report to the organizer for distribution to the chapters.
- To review amended local chapter bylaws and standing rules and forward appropriate comments to the president of the local chapter.
- To prepare a display of yearbooks at convention.
- To have the minutes of convention of state chapter approved by the president who presided at the convention before the minutes are printed in the proceedings.
- To have the proceedings of convention and the current bylaws and standing rules of the state chapter compiled and printed within three months following convention.
- To furnish electronic copies of the Proceedings and Bylaws and Standing Rules of Alabama State Chapter to the P.E.O. Executive Office as directed, the executive board of the state chapter, members of the Amendments and Recommendations Committee, members of the Finance Committee, the Historian, and the Alabama P.E.O. website. Submission to the P.E.O. Executive Office shall include two PDF files: the proceedings including the bylaws and standing rules, and a separate, "stand-alone" bylaws and standing rules document. To furnish hard copies to the executive board members, the immediate PSP, and those PSPs without access to email.
- To notify local chapters entitled to representation in Convention of International Chapter by November 1 of the year prior to the convention.
- To serve as adviser to the P.E.O. International Peace Scholarship and Scholar Awards Committees.

#### ARTICLE V -- FINANCE

<u>Section 1—DUES</u>. The annual dues of Alabama State Chapter shall be fifty-one dollars (\$51.00) per active member, which shall be allocated as follows: Thirty-six dollars (\$36.00)\* for International Chapter dues, which shall include six dollars (\$6.00) for Cottey College; and fifteen dollars (\$15.00) for state chapter dues.

\*PROVISO: The increase of International Chapter dues to thirty-six dollars (\$36.00) shall be implemented in two steps; an increase of five dollars (\$5.00) to thirty-one dollars (\$31.00) to for the 2024-2025 fiscal year; and an increase of five dollars (\$5.00) to thirty-six dollars (\$36.00) beginning the 2025-2026 fiscal year. The total annual dues of the Alabama State Chapter shall be forty-six dollars (\$46.00) for the 2024-2025 fiscal year and fifty-one dollars (\$51.00) beginning the 2025-2026 fiscal year.

<u>Section 2—CONVENTION FEES.</u> Each local chapter shall send annually with the dues the following fees for the State Convention Fund.

- A convention fee of three dollars (\$3.00) per active chapter member.
- A registration fee of fifty dollars (\$50.00) per local chapter.

#### Section 3—STATE RESERVE FUND.

- Establishment. Alabama State Chapter shall establish and maintain a fund to be known as the State Reserve Fund.
- Funding. Initial funding shall be by transfer from the Alabama State Chapter General Fund.
   Initial funding and additional transfers in or out shall be recommended by the Finance Committee and approved by vote of the members of convention of Alabama State Chapter.
- Requirements. The fund shall be administered by the treasurer of Alabama State Chapter at the
  direction of the executive board.

Purpose. The purpose of the State Reserve Fund is to be a savings fund. The goal is to maintain
a minimum balance equivalent to one year's operating expenses of the Alabama State Chapter.

#### Section 4—STATE CONVENTION FUND.

- Establishment. Alabama State Chapter shall establish and maintain a State Convention
  Fund for the purpose of paying those expenses incurred to conduct the annual
  Convention of Alabama State Chapter.
- Funding. The State Convention Fund shall be funded according to ARTICLE V FINANCE, Section 2 CONVENTION FEES. Transfers in or out shall be recommended by the Finance Committee and approved by vote of the members of convention of Alabama State Chapter.
- Requirements. The fund shall be administered by the treasurer of Alabama State Chapter at the direction of the executive board.
- Purpose. The purpose of the State Convention Fund is to eliminate the need of hostess chapters raising funds to pay for costs of convention.

#### Section 5—CONVENTION OF STATE CHAPTER.

- A. The state chapter shall pay the expenses of convention from the State Convention Fund in accordance with the State of Alabama Executive Board Duties, Guidelines and Policies.
  - An annual allocation shall be made to the hostess chapters' convention account to assist with expenses incurred for the ensuing convention.
    - Any surplus in the account shall be returned to the State Convention Fund by the hostess chapters.
    - Any deficit incurred in the account will be repaid to the State Convention Fund by the hostess chapters.
  - B. Hostess chapters shall send their estimated costs to the executive board.
  - C. Each local chapter shall pay the travel, housing, and meals of their delegates.

Section 6—CONVENTION OF INTERNATIONAL CHAPTER. The state chapter shall pay the registration fee and the transportation expense based on the most economical method of travel to the Convention of International Chapter of its president, vice president or her alternate, and the local chapter delegates. The state chapter shall pay the transportation expense of the immediate past president of the state chapter based on the most economical method of travel provided she has not attended a previous Convention of International Chapter at state expense. Past presidents of the state chapter attending the Convention of International Chapter (whether or not they are entitled to housing and meals) shall pay their own registration fee and travel expenses. The state chapter will incur the cost of housing, at a half-room rate, when it is necessary for entitled members of convention to arrive the day before the start of convention activities. The state chapter will incur the cost of a Credentials Dinner at the Convention of International Chapter (CIC) to be organized by the state president, and attended by state delegates, entitled PSPs, and state officers attending as delegates. Others may attend the dinner at their own expense.

The state chapter will pay incidental expenses incurred by entitled PSPs, delegates, and state officers attending CIC as delegates. Reimbursements shall be made in accordance with the State of Alabama Executive Board Duties, Guidelines and Policies and will be made upon submission of receipts or other documentation within six weeks of attending Convention of International Chapter.

<u>Section 7—EXECUTIVE BOARD AND COMMITTEES</u>. Members of the Executive Board of Alabama State Chapter and standing committees, when traveling on official business, shall be paid for

necessary housing unless otherwise provided, and for traveling expense by car at a rate approved by the Executive Board of Alabama State Chapter that closely conforms to the rate paid by International Chapter or a sum not to exceed tourist class air fare.

Office expenses as authorized by the executive board shall be paid from the general fund and shall be reimbursed only by documented receipts submitted within three months of the date they were incurred.

#### ARTICLE VI -- STANDING COMMITTEES

#### Section 1—AMENDMENTS AND RECOMMENDATIONS.

- Appointment. The Amendments and Recommendations Committee shall consist of three members, each of whom shall serve three years. One member shall be a past president of the Alabama State Chapter. One member shall be appointed each year by the incoming president with approval of the executive board. The senior member in years of service shall be Chair. In case of the appointment of an entirely new committee, the president shall designate the Chair, second and third members.
- · Duties. The duties of this committee shall be as follows:
  - To consider all amendments, recommendations and resolutions to come before convention
    of the state chapter; put such proposals into correct parliamentary form; and present same
    to convention.
  - To send a copy of the proposed amendments, recommendations and resolutions at least thirty days before convention of the state chapter to the following: local chapters, members of the executive board, members of all standing committees and past presidents of state chapter.

#### Section 2—FINANCE.

- Appointment. The committee on finance shall consist of three members, each of whom shall
  serve three years. One member shall be a past president of the Alabama State Chapter. One
  member shall be appointed each year by the incoming president with approval of the executive
  board. The senior member in years of service shall be chair. In case of the appointment of an
  entirely new committee, the president shall designate the chair, second and third members. The
  vice president and treasurer of the state chapter shall be ex-officio members, without vote, of
  this committee.
- · Duties. The duties of this committee shall be as follows:
  - To become familiar with the finances of the state chapter and to consult and advise on financial matters with the executive board.
  - To prepare a budget for the state chapter for the ensuing year, and to present this budget for consideration at convention of the state chapter. A copy of this budget shall be placed in the kits of members of convention.
  - To recommend any necessary transfer of funds.

#### Section 3—HISTORIAN.

- Appointment. The committee on history shall consist of one member appointed each year by
  the incoming president with approval of the executive board. She shall be a member of a chapter
  in the city where the convention of state chapter is to be held, when feasible.
- Duties. The duties of this committee shall be as follows:
  - To collect and record data relative to P.E.O. in Alabama.
  - To compile information from local chapter presidents' letters.
     To present a summary of letters and data at each Convention of the Alabama State Chapter.
  - To serve as custodian of memorabilia which the historian and executive board deem advisable to be retained by the state chapter.

#### Section 4—ALABAMA COTTEY COLLEGE SCHOLARSHIP AND RECRUITMENT.

- Appointment. The committee of Alabama Cottey College Scholarship and Recruitment shall
  consist of three members, each of whom shall serve three years and each selected from different
  geographical areas of the state. One member shall be appointed each year by the incoming
  president with approval of the executive board. The senior member in years of service shall be
  chair. In case of the appointment of an entirely new committee, the president shall designate
  the chair, second and third members. The vice president shall be the adviser.
- · Duties. The duties of the committee shall be as follows:
  - o To promote Cottey College statewide.
  - o To provide Cottey College information to local chapters.
  - To award scholarships when funds are available as determined by the executive board by March 1 of each year.
  - To renew the scholarships for a second, third and fourth year upon application by the students.
  - To prepare a display and provide a speaker for convention of state chapter.
  - To report annually to the convention of state chapter.

#### Section 5—NOMINATING. (See Article III, Section 3)

#### Section 6—MEMBERSHIP.

- Appointment. The committee on membership shall consist of four members, each of whom shall
  serve four years. One member shall be appointed each year by the incoming president of state
  chapter with the approval of the executive board. The senior member in years of service shall
  be chair. In case of the appointment of more than one new member the president shall designate
  the chair, second, third, and fourth and terms of the members. The organizer shall serve as the
  adviser to the committee.
- Duties. The duties of this committee shall be as follows:
  - To promote membership statewide.
  - o To provide membership guidance to local chapters
  - To prepare a membership display for state convention.
  - o To assist the organizer with membership issues.
  - To report annually to the convention of state chapter.

<u>Section 7—PHILANTHROPIES.</u> P.E.O. Educational Loan Fund, P.E.O. International Peace Scholarship, P.E.O. Program for Continuing Education, P.E.O. Scholar Awards, and P.E.O. STAR Scholarship.

- Appointment. Each committee shall consist of two members, each of whom shall serve two
  years. One member shall be appointed each year by the incoming president of state chapter
  with the approval of the executive board. The senior member in years of service shall serve as
  chair. In case of the appointment of an entirely new committee, the president shall designate
  the chair and second member.
- Advisers. The treasurer shall serve as adviser to the P.E.O. Educational Loan Fund and the
  P.E.O. Program for Continuing Education Committees; the secretary shall serve as adviser to
  the P.E.O. International Peace Scholarship and the P.E.O. Scholar Awards Committees; and the
  organizer shall serve as adviser to the P.E.O. STAR Scholarship Committee.
- *Duties*. The duties of these committees shall be as follows: o To promote the philanthropies statewide. o To provide philanthropy guidance to the local chapters.
  - To prepare a display and provide a speaker for convention of state chapter.
  - o To report annually to the convention of state chapter.

#### ARTICLE VII -- ALABAMA COTTEY COLLEGE SCHOLARSHIP

<u>Section 1—ESTABLISHING ACT</u>. A fund to be known as the Alabama Cottey College Scholarship Fund shall be maintained for the purpose of granting scholarships to Cottey College.

<u>Section 2—SCHOLARSHIP REQUIREMENTS</u>. Scholarships shall be granted to a resident of Alabama on the basis of character, scholastic standing, recommendation of the Cottey College Admissions Office and the approval of the Alabama Cottey College Scholarship and Recruitment Committee.

Section 3—FUNDING. The scholarship fund shall be maintained by gifts and bequests for the primary purpose of awarding scholarships to young women who are residents of Alabama desiring to attend Cottey College. The Alabama Cottey College Scholarship Fund shall be banked in a separate account; all interest accrued shall remain in said account.

Section 4—GRANTS. Women who are Alabama residents and interested in attending Cottey College may apply for a grant toward transportation expenses for participation in an official Cottey Admissions visit. The total of transportation grants will be less than ten percent of the unencumbered balance in the Alabama Cottey College Scholarship Fund in any one year. Administration of grants will be the responsibility of the Alabama State Cottey College Scholarship and Recruitment Committee and approved by the Executive Board of Alabama State Chapter.

#### ARTICLE VIII -- ORGANIZATION AND OFFICIAL VISITS

#### Section 1—ORGANIZATION OF NEW CHAPTERS.

- Requirements. The following requirements are in addition to those listed in the Constitution, Part III, Article I.
  - After a request to organize a new chapter has been received and consent given by the organizer, the prospective chapter shall have eight scheduled meetings before organization.
     Minutes of the meetings shall be kept and a copy sent to the organizer.
  - o No new chapter shall be organized within thirty days of the convention of the state chapter.
- Charter Initiates. Each charter initiate shall be recommended by a letter to the organizer of the state chapter from three active members of the sisterhood.

Section 2—OFFICIAL VISITS TO LOCAL CHAPTERS. Official visits by the organizer shall be quinquennial. However, a new chapter shall be visited annually for the first three years. Any chapter may be visited at the discretion of the Executive Board of Alabama State Chapter, or any chapter may request a visit during an unscheduled year.

The local chapter shall assume responsibility for housing and meals of the organizer or her proxy during her official visit.

#### ARTICLE IX -- SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS

The following duties are in addition to those listed in the Constitution, Part III, Article V and in the Instructions to Officers of Local Chapters.

Section 1—PRESIDENT. The duties of the president shall be as follows:

To write an annual letter and report to the president of the state chapter informing her of the
activities and status of the chapter. The letter and report shall be read and approved at a chapter
meeting in February and mailed before March 1. A copy of this letter and report shall be
retained in the local chapter president's box and copies shall be sent to absent members.

- To coordinate with elected chapter delegates to state convention so that any vacancy will be immediately filled by an alternate delegate. In the event that no delegate attends convention, the chapter shall incur a visit by a state officer, at the chapter's expense.
- To coordinate with elected delegate to Convention of International Chapter, ensuring that a
  vacancy will be immediately filled by the alternate delegate. A chapter failing to provide either
  the elected or alternate delegate will be required to reimburse the state for expenses incurred
  on her behalf.
- To ensure the delivery of the chapter yearbook as designated by the state board.

Section 2—RECORDING SECRETARY. The duty of the recording secretary shall be as follows:

 To send, in March, to the secretary of the state chapter a copy of the chapter bylaws and standing rules, if they have been amended during the fiscal year.

#### ARTICLE X - SPECIAL DUTIES OF LOCAL CHAPTERS

<u>Section 1—REPORTS</u>. The local chapter membership and philanthropy chairs shall submit annual reports by March 10.

<u>Section 2—PHILANTHROPY COMMITTEES.</u> The local chapter philanthropy chairs shall maintain permanent files.

#### ARTICLE XI – RECIPROCITY GROUPS

<u>Section 1—PURPOSE</u>. Reciprocity Groups may be formed as stated in the Constitution, Part III, Article XIII.

<u>Section 2—SUPERVISION</u>. Each group so formed shall be under the supervision of the organizer of the state chapter.

<u>Section 3—REPORTS</u>. Names and addresses of newly elected officers and contact person shall be submitted as required by International Chapter immediately following election.

Each reciprocity group shall send to the organizer of the state chapter the following:

- By March 10, the annual financial report required by International Chapter for the fiscal year March 1 through February 28/29; and
- A copy of the bylaws if amended during the year. If the bylaws were not amended, the organizer shall be so notified.

#### ARTICLE XII -- P.E.O. GROUPS

<u>Section 1—ESTABLISHMENT</u>. P.E.O. Groups may be formed as stated in the Constitution, Part III, Article XIV.

<u>Section 2—SUPERVISION</u>. Each group so formed shall be under the supervision of the organizer of the state chapter.

<u>Section 3—REPORTS</u>. Names and addresses of newly elected officers and contact person shall be submitted as required by International Chapter immediately following election.

Each P.E.O. Group shall send to the organizer of the state chapter the following:

 By March 10, the financial report required by International Chapter for the fiscal year March 1 through February 28/29;

- A copy of the bylaws if amended during the year. If the bylaws were not amended, the organizer shall be so notified; and
- · Copy of the yearbook and/or current program.

#### ARTICLE XIII -- PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern all meetings in matters not covered by these bylaws.

#### ARTICLE XIV - GOVERNING LAW

Section 1. These bylaws shall comply with governmental laws and applicable to the operation of the state chapter.

#### ARTICLE XV -- AMENDMENTS

Section 1—PROCEDURE. Amendments to the Bylaws of Alabama State Chapter shall be proposed only by local chapters, the executive board or standing committees of the state chapter and shall be submitted in writing to the Chair of the Amendments and Recommendations Committee and to the president of Alabama State Chapter by January 20. Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular meeting provided the amendment was submitted in writing at a previous regular meeting and all absent resident members notified that a vote will be taken at the next regular meeting.

<u>Section 2—VOTE REQUIRED</u>. These bylaws may be amended by a two-thirds vote of the members voting in Convention of Alabama State Chapter, provided that copies of the proposed amendments shall have been sent at least thirty days before convention to those named in Article VI, Section 1 of these bylaws.

#### EDITORIAL RESOLUTION

**Resolved,** That the 2024-2025 Executive Board of Alabama State Chapter be authorized to correct article and section designations, punctuation and cross-references and to make such other technical and conforming changes as may be necessary to reflect the intent of Alabama State Chapter.

#### STANDING RULES

- 1. The executive board of the state chapter shall determine the requirements for chapter yearbooks and shall inform the chapters of those requirements following the mid-year meeting.
  - 2. Workshops for local chapters may be scheduled at the discretion of the executive board.
- The immediate past president of the state chapter shall be responsible for the Celebration of Life at convention of state chapter.
- 4. The name of a member whose death occurs less than ten (10) days prior to convention shall appear on the Memorial Roll at convention the following year.
- 5. Both the American and Canadian flags shall be given a prominent place in convention of state chapter.
- 6. The chair of convention shall, by one month after convention, submit a complete financial report to the outgoing state president, the incoming state president, the convention Chair and chapter convention chairs for the next two conventions.

- All committees and officers of state chapter shall obtain approval from the president of state chapter before sending any form letters.
  - All P.E.O. philanthropy monies shall be sent to the state treasurer by March 1 each year.
- Amendments to the Standing Rules of Alabama State Chapter shall be proposed only by local chapters, the executive board or standing committees of the state chapter and shall be submitted in writing to the chair of the Amendments and Recommendations Committee and to the president of Alabama State Chapter by January 20. Such proposed amendments shall be adopted by a majority vote of members present and voting in Convention of Alabama State Chapter, provided that copies of the proposed amendments shall have been sent at least thirty days before convention to those named in Article VI, Section 1 of these bylaws.
